Re: Your Invitation to BC Soccer Safe Sport Assessment [Phase I Open Survey](#)

On April 15, 2019, Kjeld Brodsgaard, President of BC Soccer, sent an open letter to you and the soccer community in BC to announce that BC Soccer was moving forward on its plan to conduct a safe sport/soccer assessment to inform the organization about issues and members' perspectives on safety in soccer in BC. BC Soccer also announced that it had retained Rubin Thomlinson LLP as the independent third-party law firm for the assessment. I was selected as the project lead.

The team at Rubin Thomlinson has been working with BC Soccer to develop a three-phase plan for the safe sport/soccer assessment. Phase I of the plan is an on-line survey open to all participants in soccer in BC, available from May 15, 2019 to June 3, 2019.

This brief survey will take less than 10 minutes to complete. Anybody of any age can participate in the survey. For individuals under 16, we require confirmation of parental



or legal guardian permission. For individuals over the age of 16 and under 18, we ask that they speak to their parent(s) or legal guardian(s) prior to taking the survey.

Rubin Thomlinson is administering this survey and will collect and store all results securely. We will report the results from this survey to BC Soccer in a format that will not reveal identifying information about the respondents.

The Phase I survey and your members' participation is important. The results of this survey will guide the development of the Phase II by-invitation survey and Phase III one-on-one telephone interviews and will inform the final report to BC Soccer. It also provides the opportunity for Phase I survey respondents to volunteer for the Phase III one-on-one interviews.
