Policy Name	Youth District Boundaries

Policy Statement

BC Soccer creates Youth District geographical boundaries in consultation with the impacted Youth District Associations to provide an effective geographical operating structure for soccer in BC.

Purpose

To ensure that geographical boundaries throughout British Columbia are clearly defined and communicated to outline the areas in which soccer activities are governed by the respective Youth District Associations.

Standards

- The BC Soccer Board of Directors approves the boundaries and changes for the Youth District Associations.
- Unless approval is received from both Youth District Associations impacted, Youth District Associations and their affiliated clubs must operate all programs and soccer activities within the assigned boundaries.
- Any dispute over geographical boundaries will be reviewed by the BC Soccer Board of Directors.
- The current boundaries are:
 - **Burnaby:** Boundaries are Boundary Road on the west, East Columbia Street on the east, the Burrard Inlet on the north, and Fraser River on the south.
Communities in the district include but are not limited to: Burnaby, New Westminster.
 - **Cariboo:** Boundaries are 53rd parallel in the north, the Alberta border and highway 5 to the east, highway 99 to the south, and the Pacific Ocean to the west.
Communities in the district include but are not limited to: Crescent Spur, Goat River, McBride, Dunster, Croydon, Tete Jaune Cache, Blue River, Stoner, Hixon, Dunkley, Wingdam, Barkerville, Quesnel Forks, Quesnel, Australian, McLeese Lake, Williams Lake, 100 Mile House, Horsefly, Black Creek, Hendrix Lake, Mahood Falls, Canim Lake, Albreda, Lac la Hache, Saint Joseph Mission, Bridge Lake, Copper Creek, 70 Mile House, Chasm, , Cache Creek, Dog Creek, Riske Creek, Hanceville, Lees Corner, Alexis Creek, Redstone, Chilanko Forks, Tatla Lake, Gold Bridge, Bralome, Nimpo Lake, Birtvale, Stuie, Bella Coola, Nazko, and Kemano.
 - **Central Okanagan:** Boundaries are the 50th parallel to the north, the 49th parallel to the south, highway 1 to the west, and upper arrow lake to the west

 - **Fraser Valley:** Boundaries are 196th street on the west, 49th parallel to the south, highway 7 to the north and highway 3 to the east.

- **Haida Gwaii:** Boundaries are the Pacific Ocean surrounding Haida Gwaii for all borders

Communities in the district include but are not limited to: Masset, Port Clements, Tlell, Queen Charlotte, Sandspit, Skidegate, Alliford

- **Kootenay Rockies:** Boundaries are upper arrow lake to the east, the Alberta border to the west, the 49th parallel to the south, and highway 1 to the north

- **Northern Interior:** Boundaries are the BC borders to the north, east, and west, and the 53rd parallel to the south.

- **North Fraser:** The boundaries are East Columbia Street to the west, the northernmost part of Coquitlam to the north, the Fraser River to the south, and 280th street to the east

North Island: Boundaries are Upper Island to the south, the Johnstone strait to the east, and the Pacific Ocean to the north and west.

Communities in the district include but are not limited to: Port Hardy, Port McNeill, Port Alice, Alert Bay, Kyuquot, Nimpkish, Beaver Cove, Jeune Landing, Coal Harbour, Nigei Island, San Josef Bay

- **North Shore:** Boundaries are the northernmost part of Pemberton and Highway 99 to the north, the Burrard inlet to the south, highway 1 to the east and the Pacific Ocean to the west

Communities in the district include but are not limited to: Pemberton, Nelson Island, Edgmont, Madeira Park, Halfmoon Bay, Sechelt, Roberts Creek, Gibsons, Squamish, Woodfibre, Britannia Beach, Furry Creek, Whistler, Garibaldi, North Vancouver, West Vancouver

- **Richmond:** Boundaries are the Fraser River to the north, south, and east and the Pacific Ocean to the west.

- **South Fraser:** Boundaries are 196th street to the east, the 49th parallel to the south, the Fraser River to the north, and the Pacific Ocean to the west
Communities in the district include but are not limited to: Tsawassen, Ladner, Delta, Surrey, White Rock, Langley
- **Thompson Okanagan:** Boundaries are the 50th parallel to the south, Upper Arrow Lake until Highway 1 and the Alberta border to the west, Highway 5 to the east until Kamloops and Highway 1 south of Kamloops

Communities in the district include but are not limited to: Powell River, Lake Cowichan, Ladysmith, Cassidy, Nanaimo, Nanoose Bay, Parksville, Nahmint, Port Alberni, Beaver Creek, Bowser, Fanny Bay, Denman Island, Lasqueti Island, Texada Island, Ucluelet, Long Beach, Tofino, Ahousat, Cumberland, Courtney, Merville, Black Creek, Oyster River, Campbell River, Herior Bay, Flores Island, Yuquot, Nootka Island, Kendrick Camp, Ceepeecee, Queens Cove, Zeballos, Woss, Tahsis, Vernon Lake, Gold River, Gabriola,
- **Vancouver:** Boundaries are the Burrard Inlet to the north, the Pacific Ocean to the west, Boundary Road to the east, and the Fraser River to the south
Communities in the district include but are not limited to: Vancouver, University Endowment Lands

Definitions

- Youth District Association – An association established under the jurisdiction of BC Soccer for the purpose of organizing and administering youth soccer in a defined area in accordance with this policy.
- Inter-District activities – Any soccer activity involving clubs from two or more Youth District Associations.

Guidelines

Youth District Associations can collaborate with bordering Districts to promote Inter-District activities with the approval of BC Soccer
